Dear all,

Samavedana takes pleasure in sending this report to you as the end of first quarter of FY 2016-17.

As every year, the quarter was full of events. In fact, Samavedana is becoming a more happening platform, due to community interventions and the clinic. We started with preparations for the 13th annual program. Famous artist *Mr. Sharad Ponkshe*, as a Chief Speaker, won the hearts of huge crowd flooding the hall, with his emphatic speech on *Veer Savarkar*. *Mr. Dinesh Deo*, CMD, BNY Mellon India graced the occasion as Chief Guest. We are thankful to 'Mother's recipe' for taking Main Sponsorship of the event.

A corporate donor had contributed a sum of Rs 20 lac last year to be used for cardiac surgeries for kids with congenital defects. We are very happy to announce that these funds have given a new lease of life to 37 children.

This year, we have geared up our activities under the domain of 'Health Education and awareness' targeting women and adolescent girls from the urban slum community. We organized 6 lectures benefitting 204 participants. Along with this, we have started check-up camps for urban areas also, under CSR of various corporate. We conducted 6 camps in urban and rural areas covering more than 800 women and children. In association with a corporate, we finished 2nd dose of Hepatitis B vaccination for students from 5 Zilla Parishad schools in Khandala Taluka, dist. Satara.

This year, our main focus is settling down of the clinic. A number of activities like Gynaec Check-up camps, free blood sugar and BP check-up camp were organized to help people know about the clinic and the facilities. Today, at the end of 4 months of existence, there are 8 patients daily visiting the clinics, with full trust on the doctor. A number of 'families' also take regular benefit of the clinic. By now, the clinic is fully equipped with facilities for pathology investigations, ECG & X Ray. Now, we are planning speciality clinics at the clinic.

I am sure we will have more of positive news in the coming quarter as well since we have got off a great start for one of our ambitious project : Taking healthcare to the highly neglected part of Mulshi taluka. We will need, and are confident of, your support and best wishes to see this project through.

Important Events

- Samavedana has established an association with **Yardi Foundation**, a CSR wing of Yardi Software India Pvt Ltd, for providing medical assistance for conducting **health camps in urban slums**.

The first such camp (6th April) was organized in Shankar Maharaj Vasahat, Dhanakawadi which benefited 67 children and 113 women.



The next camp from the partnership was held at Samavedana's Clinic (22nd April) at Upper Indiranagar which saw 75 women and 30 children take benefit from it.

The last camp of the quarter from this very association was organized at Padmavati (24th June) which helped 160 women and adolescent girls open their minds to specialist doctors with their health issues.

- 14th May : Samavedana celebrated its 14th **Vardhapan Din**, an annual program where we express our gratitude toward our donors and supporters. Shri. Dinesh Deo, CEO of BNY Mellon India was chief guest for the program featuring Shri. Sharad Ponshe.



Shri. Ponshe recited Veer Savarkar's thoughts and views to a gathering of 450 attendees.

- May and June: KSB Pumps has promised to donate a fully equipped vehicle which will run as Mobile Clinic in the hilly terrain of Mulshi. This quarter was full of activities toward realizing this project. Team Samavedana made visits to Mulshi area as well as government facilities in the vicinity. Dr Karanjkar. THO of Mulshi Tehsil has pledged full support for the project.
- 17th, 20th and 21st June: As an extension of **school health program** we started in March, we conducted health check and vaccination camp for about **450 ZP school students** from Khandala taluka. The program also included **gynec health check up** of 76 women. The program was completely sponsored by a company under their CSR folio.

Patient's Summary:

We helped as many as 35 new patients during this quarter of which 19 are female. Of these 10 were from Neurology/surgery department where 8 were looked after by team of cardiologists. 5 patients were admitted for orthopaedic medical assistance.

Sahyadri Hospital's Karve Road, Deccan unit admitted the most number of patients which

Akshay underwent liver transplant surgery, and recovered well. The family already had borne huge amounts during the transplant. His father, a wireman in Mumbai, his savings were exhausted. After discharge, he developed complaints of left sided weakness and difficulty in walking. Radiological imaging was suggestive of congenital multiple deformities in the region of base of skull and 1st two vertebrae in cervical region.

It was compressing the cervical cord, creating weakness of legs, more on the left side. The only option for correction was surgery to decompress the cord and correction of deformities by fixation of vertebrae. Understanding the need of surgery as well as family's financial helplessness, Samavedana decided to support Akshay. He underwent the surgery and post operatively, he improved neurologically. At the time of discharge, he was ambulant with support.

If not for the surgery, Akshay would have recovered from liver damage but could have been bed-ridden for all his life. Samavedana is happy to support this boy to be back on his feet and be an asset to his family and society.

We are thankful to Sahyadri Hospital, Deccan Gymkhana for subsidizing the bills and doctor's team for waiving off their fees for Akshay's treatment. The balance amount of Rs. 1 lac was contributed by Samavedana.
